About the workshop

The topic is "Planning for sustainable city logistics policies and measures in small and mid-sized European cities".

The purpose is to network and disseminate the intermediate results of the 9 small and medium-sized European cities in the ENCLOSE project and to take advantage of the Nordic experience on sustainable city logistics. The workshop is an opportunity to discuss common issues, challenges and results together with a number of European municipalities.

ENCLOSE stands for 'Energy Efficiency in City Logistics Services for small and mid-sized European Historic Towns' (www.enclose.eu). The project is funded by the European Commission under the Intelligent Energy Europe (IEE) program that supports organizations working for sustainable energy. The project runs from May 2012 to November 2014 and its main goal is to create energy efficient and sustainable city logistics in European small and medium-sized historic towns with effective practical measures that provide substantial environmental improvements and benefits. The project aims to raise awareness about this challenge.
